Deposit: \$250 non-refundable deposit/ Booking fee to save date

The deposit is due on signing this agreement (Deposit of \$250) with the balance of the amount agreed due 5 days before the day of the wedding.

Entire Agreement: This agreement contains the entire understanding between the Clients and the Photographer.

Confirmation: A signed “Contract for Wedding photography” and payment of the deposit are necessary to confirm the stated wedding services for the Photographer.

Pre-Wedding Consultation: This normally happens at the time of booking. The clients will broadly outline what is required and the Photographer will advise on what they are able to provide.

Cancellations: Any cancellations will require a **cancellation fee** of 35% of the amount of the package you booked to be paid at the time of cancellation.

Late Payments: Any payments made after the agreed upon dates between the Photographer and the Clients will start to accrue a weekly interest rate of 18%. For example, if you have a balance of \$1400, and it is not paid until a month after the wedding day, the owed amount will be \$2408 ($\$1400 * 18\% = \252) ($\$252 * 4 \text{ weeks} = \1008) $\$1008 + \$1400 = \$2408$

Payment Plans: Payment plans can be made before the wedding date without interest added. Any payments plans created after the due date will be agreed upon by the Clients and the Photographer and will have a weekly accrual of 18% interest on the late payments.

Itinerary Fee: Needing a little help with your itinerary? No worries! For a **charge of \$150** Perkyphotos will draft an itinerary, and have it to you before the day of the wedding.

Photo loss/ Retrieval Fee: Lose some photos in the uploading process? No worries! One way or another clients can end up losing their photos by removing the usb too early, or various other actions that can result in photo loss. All weddings are backed up for up to 3 months after the wedding date, but a **\$50 Retrieval fee** will be charged if user error causes the photos to be lost. All packages include full instructions on how to upload all files to one's computer or hard drive.
